The Director, ARIES, Nainital, invites online tenders from experienced civil contractors those who have experience to work in hilly regions and **Registered as contractors/firms Class ‘A’ or ‘B’ with CPWD/Uttarakhand State PWD or with other Central / State Government Offices for civil & electrical associated works** for ARIES at Manora Peak and Devasthal campus.

- f) The Director, ARIES, Nainital reserves the right to reject any or all tenders.

Eligibility Criteria:

- a. The bidders shall clarify/state whether he/they has sufficient experience in similar job mention in NIT. The offers of contractors/ firms who are not doing similar nature of jobs will be summarily rejected.
- b. In support of experience mentioned in the technical bid, copies of successful completion certificates **of two similar works (Civil works) costing Rs 10.0 lacs (Ten Lakh)** each during the last three financial year's form any State/Central govt. departments should be enclosed with the technical bid. For, the current financial year if completion certificate is not available, then bidder can enclose the certificate or copy of the orders received.
- c. Bidder must submit documentary evidence in support of above point in the form of certified copy of the work order, completion certificate, payment certificates/vouchers indicating the period of work for which the payment was made.
- d. In support of experience and work completion, if documents /certificate are not enclosed, the bid will be summarily rejected.
- e. **The bidder must submit all relevant documents as specified in the criteria of eligibility. Shortfall documents following the procedure specified in CPPP may be asked at the discretion of the competent authority to the satisfaction that it is essential and will not substantially delay the tender process.**
- f. **Bidder should have valid registration with Employees Provident Fund organization under "EPF and Miscellaneous Provisions Act, 1952: A copy of the same may be attached with the technical bid.**

Submission of Bids:

- a. Bid should be submitted in two bids system containing two parts as detailed below:-
 - Part-I: **Technical bid** with bid security declaration.
 - Part-II: **Financial bid**

Note:

- i. In financial bid, bidders should give rates, including all taxes. Tender not conforming to this requirement shall be rejected and no correspondence will be entertained whatsoever.
- ii. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity, access, facilities for workers and all other services required for executing the work.

- iii. The price Bid should be submitted online. ARIES authorities reserve the full rights to increase or decrease the quantities of items, at the time of award of contract and at any time during execution of contract period or extended period of contract as per its actual requirement.
 - iv. The Director ARIES, Nainital reserves the right “that it is not necessary that all the items will be executed in the said period of the contract and therefore the contractor has no right to claim for any works/item of works for the execution in the time period of contract or extended period of the contract.”
- b. The intending bidder shall have to furnish attested copies of the following documents with the technical bid.
- i Proof of executing two civil works worth of the value 10.0 lakhs each in last three financial years (eligibility criteria mention in point C)
 - ii Copies of valid certificates of Income Tax clearance, Service Tax, PAN number, and any other tax applicable for the Last Three years.
 - iii Details of contractor/firms/ company in case of partnership firms.
 - iv Copies of EPF & ESI registration details, if applicable.
 - v GST registration.
- c. No rates should be indicated in the Technical bid. The Technical bid documents including Bid Security Declaration as required in the tender document should invariable be accompanied with the Technical bid. **Tender without EMD / Exemption certificate will not be considered.**
- d. The bid document should be paged and a certificate to this effect must be provided on the covering letter indicating the number of pages submitted along with the bid.
- e. Taxes, Terms and conditions **for providing services for the civil associated works** are invariably indicated. **The rate inclusive of all taxes may be quoted in the financial bid online.**
- f. The bidder should furnish a certificate that the firm has not been blacklisted in the past by any government/Private institution. The bidder has to give an undertaking as given at Annexure-IV that there is no vigilance/CBI/FEMA case pending against the firm/contractor and the firm has not been blacklisted in the past by any Govt. or Private organization.
- g. The competent authority on behalf of the “**Director, ARIES, Nainital**” does not bind himself to accept the lowest or any other bid and reserve to itself the authority to reject any or all the bids received.
- h. Any bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate put forth by the bidders, shall be summarily rejected.

Award of work:

This notice inviting bid shall form a part of the contract document. The successful bidders/contractor shall sign the contract within 5 days of issuing the work order from ARIES. The contract document will consist of:

- a. The NIT, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and
- b. Acceptance thereof together with any correspondence leading thereto.

Payment terms and condition:

- a. Payment shall be released after the successful completion of the items of work and on receipt of bill after deducting TDS.
- b. Part payment may be released at the request of the contractor against part of the work quantity on arrival of the materials at the site and it will be adjusted on completion of 100% work completion of the said work duly accepted by the contractor while making final payment bill of the contractor.
- c. The works of the entire items shall have to be completed within the stipulated period. 100% payment will be made after supply, subject to submission of Performance Guarantee at the time of issue of order @ 5% value of work order (Value of the work order to be awarded).
- d. This guarantee shall be in the form of online submission to ARIES or deposit at call receipt of any scheduled bank/Banker's Cheque/Demand Draft /Pay order of any Scheduled Bank or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank in accordance with the prescribed form valid for 12 months. The security guarantee will be released after 15 months after full satisfaction of the work.
- e. The firm/contractor will have to complete the entire quantity of work at ARIES Campus at Manora Peak directed by the competent authority nominated by Director, ARIES. Loading/unloading of goods, transportation, delivery material up to the site of the work shall be the responsibility of the bidder and no extra cost should be quoted for the same. In case of delay on the part of the contractor's penalty @ 0.5% per week of the total value of work as billed will be deducted from the contractor's bill subject to maximum of 10% without any prejudice to other terms & conditions.

Conditions of contract:

- a. The contractor shall start the work after receiving duly signed work order, design/layout (if required) and the extenuated cost of the work. The above needs to be completed with the said estimated cost. However, in situation beyond the control of the contractor, written in the approval of the competent authority shall be taken.
- b. Deployment of manpower: Contractor should be qualified and well experienced to operate the all type of civil & electrical works and attend to the related works of such nature. Any other manpower required shall be made available by the contractor for proper functioning and will be in the scope of contractor. The contractor will employ a supervisor from his side to monitor and supervise day-to-day work and report to the concerned officer of ARIES. Proper supervision of contractor's has to be provided to oversee the whole work for the smooth operation and maintenance services as and when required shall be recorded in the MB/Log-Book.
- c. Terminology & scope for this project shall be as per CPWD Specification. For measurement CPWD specifications shall be followed. Where not available, BIS/Engineering practice as directed by the Engineer from ARIES shall be followed.
- d. All materials used on the works shall be new and of the best quality available, conforming to the relevant specifications and as per good engineering practice. Prior approval shall be obtained in writing from the Engineer of ARIES for all materials proposed and when necessary.
- e. Monitoring of Progress of work: The progress of work done by the contractor will be checked and monitored from time to time. Site inspection of work will be done at various stages.
- f. Measurement book: For recording of works related to civil & electrical, shall be provided and maintained by the Department i.e. ARIES, Nainital showing the complete working done. The same shall be duly signed by the contractor & In-Charge civil work before presented for the payment.
- g. Contractor is expected to furnish all labour & material in sufficient quantities at appropriate time, expedite and schedule the work to meet the work requirement and shall manage the operations that the work is completed within time as stated elsewhere.
- h. Contractor shall plan his work in such a way that items of work requiring presence of Engineer are carried out between 9 A.M. & 5:30 P.M. on working days.
- i. Completion certificate: On completion of these works if carried out at site during the contract, a certificate shall be furnished to the Engineer, by the Contractor, counter signed by the contractor/supervisor under whose direct supervision the work completion on the basis of this certificate the final payment shall be released after deductions as per rules.

General Terms & Conditions:

- a. After awarding the contract, in case of non-supply of items for repairs within the due date i.e. within the date of delivery as well as non-completion of work with the date of stipulated period, the **Director, ARIES, Nainital** will have the right to impose penalty, as deemed fit LD.
- b. The Director, ARIES, Nainital shall be the final authority to reject full or any part of the payment which is not conforming to the specification and other terms and conditions.

- c. Bidders submitting tenders would be considered that they have accepted all the terms and conditions.
- d. **The volume of work quantizes, however, during the contract, it may vary either increased or decreased depending upon the actual the site requirement and conditions.**
- e. Any action on the part of the bidder to influence anybody in the Institute will be taken as an offence, he (they) will not be allowed to participate in the tender enquiry and their offer will not be considered.
- f. Work done should be conforming to the specifications as decided by the Competent Authority, material conforming to different standards.
- g. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site works for maintenance, the means of access to the site, the accommodation they may require and in general obtain all necessary information and other circumstances which may influence or affect their bid.
- h. Submission of a bid by bidders implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done & local conditions and other factors having a bearing on the execution of the work.
- i. The execution of the work accordance in all respects with the specifications, designs, drawings and instructions of Competent Authority, be completed in the stipulated time as given in tender document.
- j. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be summarily rejected.
- k. The bidder shall furnish the following certificate to the ARIES, Nainital along with each bill for payment for the work done made against in Item Rate Contract Tender.

“I/We certify that the material put on the site is identical to the previous material as put there for construction and the bill be made including all costs of material and labor applied to the work under the contract. Up to date of bill/the date are submitted against the completion of work as per the currency of the tender/rate in the contract and at the rate quoted in the tender”.

- l. **Door Delivery:** The offer of the contractor should also include the cost of transportation of materials from their show room/ Go-down to aforementioned place and placement at the location indicated by the Competent Authority or engineer of ARIES.
- m. **Quality of goods & Works:** The firm/contractor will be entirely responsible for quality of items installed at any place and quality workmanship is required. The contractor should replace the rejected /damaged materials without involving any type of extra cost & repair the same and remove

all sorts of debris materials from all the places and clean the floor walls etc. Contractor cannot deny any sort or kind of work i.e. repairs in lat./bath changing w/c, urinal pots etc.

- n. The work done should be as per the specifications as approved by the competent authority no defects should appear and the repair work should be done with quality workmanship to appear as good as in shape.
- o. The performance guarantee deposit will be forfeited in case of violation of the terms and condition of the contract.
- p. **The bidders are advised to see CPPP Website regularly as the Corrections /modifications in the Schedule of items, terms, conditions shall only be made through website at any time but before the last date of receipt of tender.**
- q. The contractor shall not be permitted to bid for works in the ARIES Project, responsible for award and execution of contracts, in which his near relative is posted. He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any staff of ARIES or working in the Department of Science & Technology (DST), GoI.
- r. No Engineer of gazetted Rank or other Gazette Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service. (all engineering department or only civil)
- s. The bid for the works shall remain open for acceptance for a period of Ninety (90) days from the date of opening of financial bid, if any bidders withdraws his bid before the said period or before issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the ARIES shall, without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.
- t. Statutory liability will be dealt as per Govt. norms
- u. Subletting of tendered work is not permitted to any other bidder.
- v. In the event of any legal dispute under this agreement, the jurisdiction will be the court at Nainital.

w. Engineer at Liberty to Object:

The Engineer shall be at liberty to object to and require the contractor to remove forthwith from the works any person provided by the contractor who, in the opinion of the Engineer, misconducts himself, or is incompetent or negligent in the proper performance of his duties, or whose presence on the site is otherwise considered by the Engineer to be undesirable, and such person shall not be again

allowed upon the works without the consent of the Engineer. Any person so removed from the works shall be replaced as soon as possible by a qualified person and approved by the Engineer.

x. Safety, Security and Protection of the Environment:

The Contractor shall, throughout the execution and completion of the works and the remedying of any defects therein:

- i) Have full regard for the safety of all persons entitled to be upon the site and keep the site (so far as the same is under his control) and the works (so far as the same are not completed or occupied by the Employer) in an orderly state appropriate to the avoidance of danger to such persons, and
- ii) Provide and maintain at his own cost all lights, guards, fencing, warning signs and watching, (when and where necessary or required by the engineer or by any duly constituted authority), for the protection of the works or for the safety and convenience of the public or others.
- iii) Take all reasonable steps to protect the environment on and off the site and to avoid damage or nuisance to persons or to property of the public or others resulting from pollution, noise or other causes arising as a consequence of his methods.

y. Damage to persons and property:

The Contractor shall, except if and so far as the contract provides otherwise, indemnify the employer against all losses and claims in respect of:

.

z. Accident or injury to workmen:

ARIES shall not be liable for or in respect of any damages or compensation payable to any workman for death or injury resulting from any act or default of the contractor. The Contractor shall indemnify and keep indemnified ARIES against all such damages and compensation and expenses whatsoever in respect thereof or in relation thereto. The Contractor shall take out appropriate insurance to cover workers, staff and particularly labors.

Amicable Settlement of Dispute:

The party shall use their best efforts to settle amicably all disputes arising out of or in connection this contract or the interpretation thereof.

The contractor has also comply the following:-

- That the normal functioning of ARIES activity is not affected as far as possible.
- That the work is carried out in an orderly manner without noise and obstruction to flow of traffic.
- That all rubbish etc. is disposed off at the earliest and the place is left clean and orderly at the end of each day's work.

- The Contractor shall ensure that his civil and electrical staff is qualified for their part of work. He shall be responsible for their conduct. The staff should behave in a courteous manner. The contractor shall be held responsible for any loss or damage to ARIES property.
- The contractor shall ensure safety of his workers and others at site of work and shall be responsible for any consequence arising out of execution of the Civil and Electrical work/job works.
- When instructed to do so, the contractor shall ensure proper record keeping and storing of irreparable/dismantled material.
- Water and electricity shall be his own arrangements by the selected contractor. The responsibility for following relevant rules, regulations and laws in this regard shall be entirely that of the contractor. The same be used carefully, any miss happening the contractor shall be solely responsible for that.
- **The water and electricity, if supplied by ARIES to the construction agency, the tap point will be provided at one point and the construction agency will pay 5% separately for (water and electricity) of the contract value towards the water and electricity advance amount @10% and the same shall be deducted from each running bill of the contractor.**

Special Teams and Conditions:

- **Engineer's Duties and Authority**

The Engineer shall carry out the duties specified in the Contract

- **Custody and Supply of Drawings and Documents :**

The Drawings shall remain in the sole custody of the Engineer, but copies as required thereof shall be provided to the Contractor free solely for the purpose of this contract. The works are of civil & electrical therefore drawing will remain with the Engineer.

- **Sufficiency of Tender :**

The Contractor shall be deemed to have based its tender on the data made available by the ARIES and on his own inspection and examination of the site conditions.

- **Compliance with Statutes, Regulations :**

The Contractor shall conform in all respects, including by giving of all notices and the paying of all fees, with the provision of: (a) Any National or State Statute, Ordinance, or other Law, or any regulation, or bye-law of any local or other duly constituted authority in relation to the operation and Maintenance Work. (b) The rules and regulations of all public bodies and companies whose property or rights are affected or may be affected in any way by the Works, and the Contractor shall keep the Employer indemnified against all penalties and liability of every kind for breach of any such provision. (c) Any changes required for approval due to revision of the local laws.

- **Extension of Time :**

Right to terminate the operation repair and maintenance contract by giving 15 days' notice at any time during the currency of the contract if the services of the agency are not found satisfactory. However,

ARIES reserves the right to extend the contract on written & mutual consent of contractor for an extended period at the same rates of earlier agreement.

• **Defect Identification and it's rectifications:**

The Contractor shall immediately attend the defects and complaints noticed at site as intimated by competent authority of ARIES. The Contractor shall provide and develop a system for regular operation, repair and maintenance of all the services which includes defects identifications and it's immediate rectification so, that services are not affected. It shall be the sole responsibility of the Operation and Maintenance agency that all the services are kept in functional condition round the clock during the currency of the contract.

• **Contractor's failure to carry out instructions :**

In case of default on the part of the contractor in carrying out repair and maintenance ARIES shall be entitled to employ and pay other persons to carry out the same and if such work, in the opinion of Director, ARIES or any person authorized by him, the contractor was liable to do at his own cost under the contract, then all costs consequent thereon or incidental thereto shall be determined by the engineer and shall be recoverable from the contractor by ARIES.

• **Measurement**

Certificates and payments as prescribed forms and running account:

- ✓ The Contractor shall submit a bill prescribed form of running account in 3 copies to the Engineer of ARIES by 7th day for the work executed in tabulated form approved by the Engineer, showing the amounts to which the contractor considers himself to be entitled.
- ✓ The measurements recorded will be signed by the contractor or its representative as a token of acceptance of the measurements.
- ✓ Details of defects/complaints attended and rectified within time.
- ✓ Details of complaints attended late.
- ✓ Attendance details of the manpower deployed during the work.
- ✓ **Computerized Measurement Book:** - All measurement of all items having financial value shall be entered by the contractor and complied in the shape of the Computerized Measurement Book having pages of A-4 size as per the format of the department so that a complete record is obtained of all the items of works performed under the contract. All such measurements and levels recorded by the contractor or his authorized representative from time to time, during the progress of the work, shall be got checked by the contractor from the Engineer- In-Charge or his authorized representative as per interval or program fixed in consultation with Engineer-In-Charge or his authorized representative. After the necessary corrections made by the Engineer-In-Charge, the measurement sheets shall be returned to the contractor for incorporating the corrections and for resubmission to the Engineer-In-Charge for the dated signatures by the Engineer-In-Charge and the contractor or their representative in token of their acceptance. Whenever bill is due for payment, the contractor would initially submit draft computerized measurement sheets and these measurements would be got checked/test checked from the Engineer-In-Charge and/ or his authorized representative. The contractor will, thereafter, incorporate such changes as may be done

during these checks/tests checks in his draft computerized measurement book, duly bound, and with its pages machine numbered. The Engineer-In-Charge and/or/his authorized representative would thereafter check this MB, and record the necessary certificates for their checks/tests checks. The final, fair, computerized measurement book given by the contractor, duly bound, with its pages machine numbered, should be 100% correct, and no cutting or over-writing in the measurements would thereafter be allowed. The contractor shall submit two spare copies of such computerized MB's for the purpose of reference and record by the various officers of the department. The contractor shall also submit to the Department separately his computerized Abstract of Cost and the bill based on these measurements, duly bound, and its pages machine numbered along with two spare copies of the "bill". Thereafter, this bill will be processed by the Office and allotted a number as per the computerized record in the same way as done for the measurement book meant for measurements.

- **Deduction of Income Tax**

The amount to be deducted towards the in compliance of income tax, laborers etc. shall be at the rate applicable.

- **Performance Guarantee**

The performance Guarantee can be encased by ARIES to recover any amount which is payable by the contractor to ARIES on any account for a cause arising out of the contract.

- **Final Certificate**

Within 28 days after receipt of the final statement of each work order and the written discharge, the Engineer shall issue Final Certificate stating: The amount which, in the opinion of the Engineer, is finally due under the Contract

- **Default of Contractor**

- ✓ If the performance of the contract and is not satisfactory and not corrected within 15 days of receiving notice, then employer shall be at liberty to terminate the contract and get the work executed through other means at the risk and cost of the Contractor.
- ✓ In the event of termination of the contract, employer shall be at liberty to get balance work done at the risk and cost of the contractor and due payment of the contractor, if any, shall be released after the completion of whole of the works.

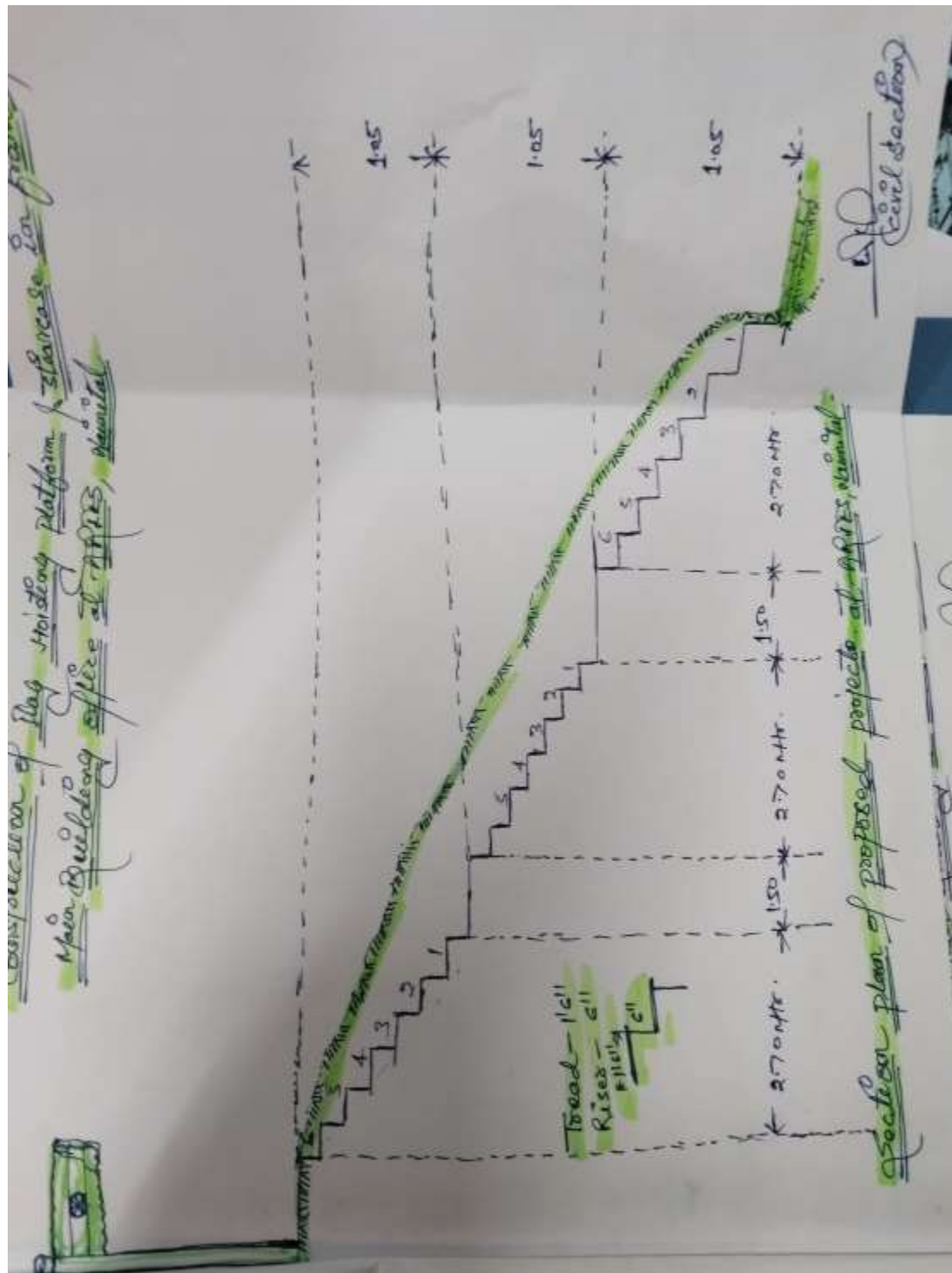
