The quotations should be dropped in the Tender Box kept at main check post. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle will be available for inspection between 2.30 PM to 3.30 P.M. from 14<sup>th</sup> March, 2022 to 17<sup>th</sup> March, 2022 (Only four days) at the main entry check post, Manora peak, Nainital.
3. The quotations received in time will be opened in Conference Room of old building. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation as submission of document evidence/I. Card/ aadhar card.
4. The auction will be governed by the following conditions:
  - i) The bidder is required to pay Earnest Money of Rs. 5,750/- (Five thousand seven hundred fifty only) means of Demand Draft drawn in favour of Director, ARIES, Nainital.
  - ii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
  - iii) The successful bidder will be required to deposit the bid amount by means of cash/demand draft drawn in favour of Director, ARIES, Nainital within two working days of the acceptance of the bid.
